## III. RESERVATIONS AND RELAXATIONS:

Reservations & Relaxations for EWS/OBC(NCL)/SC/ST/PwD/Ex. SM will be as per Presidential directives.

**Age Relaxation:** 3 years for OBC, 5 years for SC/ST; Candidates belonging to PwBD category, having minimum 40% disability or more will get 10 more years relaxation in addition to the relaxation applicable to the categories mentioned above. Further, the upper age limit is relaxed by 5 years for candidates who had ordinarily been domiciled in the State of Jammu & Kashmir from 01/01/1980 to 31/12/1989.

## IV. HOW TO APPLY:

- Eligible candidates have to apply on-line by visiting our website "www.ecil.co.in" (Main Page > Careers > Current Job Openings). The on-line application process will be operational from 26/06/2025 (14.00 hrs.) to 07/07/2025 (14.00 hrs.).
- Candidate should furnish actual information while filling on-line application form and must produce the supporting document during verification (personal, academic & professional credentials). If the candidate fails to do so, the candidature shall be rejected at any stage of recruitment process.
- After applying on-line & successful registration, the candidate is required to take the print of registered on-line application form and retain for future reference without fail. The candidate can take re-print of his/her registered on-line application form before the last date for on-line registration.
- After closing the registration process & shortlisting, an email correspondence will be sent to the eligible candidates with an advice to attend Document Verification to be held at Hyderabad.

## V. SELECTION METHOD:

- Based on data provided in On-line application, Candidates shall be shortlisted in the order of merit based on the marks obtained in ITI in the ratio of 1:4, Category wise (UR/EWS/OBC/SC/ST) and Trade wise. In case of a tie, the candidates with higher marks in Class X standard shall be considered. In case of a further tie, the candidate with earlier date of Birth shall be considered.
- Upon short listing, the candidates will be called for the Document verification to be held at Hyderabad.
- After completion of successful document verification, final list of recommended candidates will be prepared based on merit (ITI Marks, Trade & Category wise).



#### **VI. GENERAL CONDITIONS:**
