The Recruitment Rally will be held at location mentioned in Para 1 (a) to 1 (d) below. The Recruitment Rally will be tentatively conducted between Oct 2025 to Dec 2025, the exact date of reporting at rally site will be mentioned in call letters.

Quota applications are invited from eligible male and female Indian citizens for filling up 84 vacancies Male/Female shown in following sports disciplines for the post of Rifleman / Riflewoman (General Duty) under Sports Quota Recruitment in Assam Rifles for the year 2025. Ministry of Home Affairs, Government of India.

The online applications portal will be functioning from the day of publication of the advertisement to the last date of receipt of the applications as prescribed in the advertisement.

2. All further information regarding conduct of various events of the recruitment rally will be intimated to the candidates through notification on website, email and SMS only. Hence, providing functional e-mail Email ID and mobile phone number in Online Application Form by the applicants is mandatory. The mobile phone number to provide should not be OMO/terminated. The candidates will be responsible for providing of latest Email ID and mobile phone numbers in Online Application Form by them. Such information will also be made available in official website of the Assam Rifles (www.assamrifles.gov.in) from time to time.

- Age Limit of For Gen & OBC candidates: 18-25 years as on 31 Aug 2025. Candidates should have not been born earlier than 31 Aug 1992 and later than 31 Aug 2002. For SC & ST candidates: 18-25 years as on 31 Aug 2025. Candidates should have not been born earlier than 31 Aug 1992 and later than 31 Aug 2002.
- Only Matriculation Certificate or Higher Secondary School Certificate will be accepted as a proof for establishing age of the candidates.
- The candidates must fulfil all eligibility conditions and should be in possession of all sports and education certificates at the time of joining.
- All educational certificates other than Central Board/State Boards should be accompanied with Government notifications declaring the equivalence of such qualification to service under Central Government.
- The candidates seeking relaxation under OBC / ST / OBC category should submit the certificate as per prescribe format. In the event of non-availability of the certificate, the candidate will be considered under General/OBC category. Any applicant who does not fulfil the prescribed eligibility conditions, further administrative procedure will be summarily rejected.

5. **Scale of Preference**

- First preference may be given to those candidates who have represented the country in an International Competition with the Directorate of the Department of Youth Affairs and Sports.
- Next preference may be given to those who have represented a State / UT in the Senior or Junior level national Championships organized by the National Sports Federation recognized by Department of Youth Affairs & Sports or National Games organized by India Olympic Association and have won medals or positions up to 3rd rank. Between the candidates participating in Senior and Junior National Championships/Games, the candidates having participated and won medal in Senior National Championships should be given preference.

2. Assam Rifles reserves the right to make changes or sequence of the recruitment process after publication of the advertisement or to cancel/ postpone the recruitment at any stage without assigning any reason.

3. Assam Rifles reserves the right to short vacancies which in case, of non-availability of suitable candidates against the vacancies of male candidates, the same may be filled up by suitable female candidates in the same sports discipline and vice versa. In the eventuality of non-availability of suitable candidates against any particular weight category or sports discipline, the vacancies of such sports disciplines may be filled by other weight category or sports disciplines in which suitable candidates are available.

4. **How to Apply:** To apply, fill up the online application by clicking on "ONLINE APPLICATION" option on the web page. The candidates will fill the requisite details as prescribed in the application form, after filling up the application, the candidate has the option to make online payment via bank/govt for online payment or has alternatively the payment can be made at any SBI branch as well. In both the options the candidate will have to upload copy of the Application Form with Candidates write reporting for Physical Standard Test (PST), Motor Ability Test, Field Test, Interview Medical Examination (IME) & Female Medical Examination (FME). An candidate will provide original copy of payment receipt / order for official records. In case of non-uploading of receipt / challan during online registration,

- (g) Best preference may be given to those who have represented a University or an other University recognised by Association of Indian Universities / Inter University Sports Council and have won medals or positions up to 3rd place in trials.
- (h) Best preference may be given to those who have represented a State Open Tertiary University / State Schools Teams but could not win a medal or position, in the same order of preference.
- (i) Best preference may be given to those who have represented the State Sports in the National sports / games for National organised by the All India School Games Federation and have won medals or positions up to 3rd place.
- (j) Best preference may be given to those who have been awarded National Award of physical efficiency under National Physical Efficiency Club.
- (k) irrespective of levels of participation and medal won, Motor Ability Test and Field Test to respective sports will be taken before final selection.

VI. Selection Process

(a) **Candidate Verification:** The candidates in possession of valid and valid photo ID proof like Voter ID, Driving License, Aadhar Card will only be permitted to enter in the recruitment rally site.

(b) **Medical Examination:** All candidates will have to undergo examination, in which candidates will have to produce all original documents / certificates pertaining to age, education, caste or race of existing age reservation, sports and academically-earned National Certificate (NC).

(c) The candidates found correct in initial verification and documentation will only be permitted to undergo Physical Standard Test and Field Test.

(d) **Physical Standard Test (PST):** PST of candidates will be conducted by using State Frequency Measurement Device (RFDS). PST standards will be as under:

Height - sex: Chest measurement not applicable to female candidates. However, it will be considered that the chest is well developed. (a) Candidates seeking selection in height and chest will require to submit the certificate regarding their conformity from concerned District Authorities. On non-availability of the relevant certificate, they shall be considered in height and chest will not be considered and such candidates will be considered as general category candidates.

(b) **Weight:** Proportionate to height and age as per the existing medical standards as applicable to male/females.

(c) Candidates who are found eligible in PST will undergo Motor Ability Test (MAT) and Field Test.

(d) **Conduct of Motor Ability Test (MAT):** The MAT in all sports disciplines will be conducted by a Board of Officers at only one as per terms of Lakshminagar National College of Physical Education (LNCE) manual of Sports Authority of India (SAI).

(e) **Conduct of Field Test:** The Field Test in all disciplines will be conducted by a Board of Officers at rally site.

(f) Candidates who are in possession of previous sports disciplines, or, sports-related test which are requisite for Field Test in the sports discipline for the applicant, no test will be conducted by the Recruiting Agency. (g) Name will be awarded to candidates whose best performance in the Field Test. Must be an all-rounder based on performance in Field Test. In case of a tie, preference will be given as per paragraph 5. (h) Priority in the order of PST and Field Test will be considered as a reservation and pregnant female candidates shall be reported at the stage. An undertaking of not being pregnant will be taken from all female candidates before PST, MAT and Field Test. (i) Report of all will be issued to the candidates who are not qualified in PST (Motor Ability Test (MAT) and Field Test.

(j) **Approved Medical Standard Test (AMT):** Candidates declared dependent on Physical Standard Test can prefer an appeal to the Appellate Authority for re-measurement of Height and Chest etc. The appeal of the candidates shall be disposed off on the same day to the Appellate Authority.

(k) **Approved Medical Examination (AME):** The candidates who qualify in Field Test in respective sports discipline will undergo Approved Medical Examination (AME). The Medical

(2) The candidates must not have known cases, far, foot, cataract, optic, glaucoma etc. and they should undergo high colour vision test. The candidates will be tested for colour vision by ICHMANA's test as well as Deringer Green Letter Test.

(3) Must be in good normal and healthy condition and free from any physical defect likely to interfere with the efficient performance of their duties.

(4) **Colour Vision Deficiency (CVD) Test:** The process of engineering selection in trials is prevented since this provisional, but has been found to be the normal or a negligible figure. Invariably an increase of normal and usually on left side. On the other hand the present young generation is considerably under the influence of western culture and thus the number of candidates likely to be having color defect grows enormously over the years which is naturally detectable and detected from good color and discipline in the force.

(5) **Color Blindness:** Being a social ailment, the religious sentiments of our countrymen are to be respected and the colour depicting religious symbol or figure and the name as depicted in Indian Army, are to be permitted.

(6) **Leggery:** Talcoe marked on (normal) view of the body in correct aspect of dress, but only LPT I (correct) being not existing, but of the body are to be allowed.

(7) **Ear:** Size must be less than 1/2 of the particular part (Ear or Hand) of the body.

(8) **Eye:** The candidates will be examined as per the Revised Medical Guidelines 2018 issued by ADO (Medical) CAPF, WIS & AR and derived from the Guidelines for WIS & CAPF's & AR for WIS & AR's dated 21 May 2017.

(9) **Approved Medical Certificate of Approved Medical Examination:** If a candidate is declared unfit in the Approved Medical Examination (AME), the grounds for rejection will be communicated to him/her by the Recruiting Officer. If the applicant candidate is not satisfied with the findings of the Medical Officer, he/she will be allowed to undergo Revised Medical Examination (RME) provided they give their written consent to submitting their signature on the minutes indicating the reasons for being (RME). Revised Medical Examination (RME) will be conducted in continuation of Approved Medical Examination (AME) preferably on the next day of AME.

(10) The grounds for Revised Medical Examination duly signed by the candidate should be submitted within 24 hours after the date and a maximum of two test addresses in District Medical Examination.

(11) The decision of the Revised Medical Examination Board will be final and second appeal will not be entertained as per instructions of the Government and no reply of the concerned authority second appeal will be given/entertained.

(12) Being declared FIT in Medical Examination will not guarantee any appointment or job in any category for that appointment in Government service.

(13) **Final Selection Order in Service:** Final selection will be done on the basis of achievements and performance in Field Test and level of participation. There will be final order, qualifying in all tests does not guarantee the final selection into the recruitments. The final selection will only be made on the basis of position of the candidates in merit list in accordance with the availability of vacancies in the recruitment order (including in the eventuality of non-availability of suitable candidates against any particular weight category sports disciplines. The vacancies of such sports disciplines may be awarded to other weight categories disciplines in which suitable candidates are available, after the due approval of competent authority. After final selection in merit list, it will not be made only after successful completion of training by the candidates.

(14) **Health and Issue of Provisional Appointment Letter:** The candidates who qualify in all aspects of Level of professional achievement, Physical Standard Test (PST), performance in Motor Ability Test, Field Test and Medical Exam other Test will be placed in Merit List. Provisional appointment letter will be issued to the Merit list candidates.

(15) **Selection of Candidates:** To take the information furnished by the candidate in the application form to be taken in the applicant is found engaging/ engaged in another position either in India or otherwise at any stage of the recruitment, fully and even at later stages, the candidature of such candidates will be summarily rejected without any notice. Appropriate action will also be taken against such candidates as per the provisions of law by registering an FIR with the Police.

(16) The candidates will not be considered for recruitment if involved in any criminal case or in any other case under IPC or any other law of the Central Government or State Government.

(17) **Corrupt Practices:** In the ultimate recruitment process, no candidate will apply for this recruitment.

(18) **MOBILES AND OTHER ELECTRONIC GADGETS ARE BANNED WITHIN THE PREMISES OF RECRUITMENT RALLY/INTERIAL CENTRES.**

(19) **Agency Office authorities are not responsible for any type of arrangement of accommodation / food / transportation for the candidates during the recruitment process.**
