# STANDING ORDER NO. 13 /2025

# Subject-Procedure for recruitment of sports persons to the post of constable in Raissthan Police.

In supersession of earlier Standing Orders the following instructions are issued to regulate recruitment of sportspersons under Rule-7(C) of RPSSR-1989 to the post of Constable in Rajasthan Police, to be undertaken by a Sports Selection Board constituted by the Director General of Police Rajasthan for the purpose.

The Director General of Police shall be at liberty to decide the allocation of seats and games as per the requirement of the organization and also to re-affecute the seats in case of non-availability of suitable applicants, upon the recommendation of the committee constituted by the Chief Sports Officer, Rajasthan Police for this purpose. The total allocation shall not exceed the total vacancies carmarked for recruitment under Sports quota.

There shall be 2% quota for outstanding sports persons, which shall be treated as horizontal reservation and it shall be adjusted in the respective category to which the sports person belongs. In case any vacancy remains unfilled after the selection process, the vacancy shall not be carried forward but will be filled through the process of direct recruitment under the rules.

# Only candidates who are bonafide residents of Rajasthan are eligible for recruitment under this quota.

This recruitment will be governed by the latest Government circulars wherever applicable.

### AGE & RELAXATION IN AGE:

- Relaxation in age and standards of physical fitness shall be given as provided in Rules-11 and 14 of RPSSR 1989.
- (ii) The candidate must have attained the age of 18 years & must not have attained the age of 23 years (DOP notification dated 25.6.2004 and 17-05-2018) on 1st day of January of the next year following the last date fixed for receipt of applications.
- (iii) The upper age limit shall be relaced by:
- (a) 5 years in case of men candidates belonging to SC, ST, BC (non-creamy), MBC (non-creamy), EWS, Saluria category and women candidates belonging to University of category.
- (b) 10 years in case of women candidates belonging to SC, ST, BC (non-creamy), MBC (non-creamy), EWS, Saharia cutegory.
- (c) 3 years in case of the candidates who are State Government employees and dependents of deceased Police officers/Police officials killed in the discharge of their duties.
- (iv) The upper age limit mentioned above shall be 42 years (EGP notification dated 25.6.2004 and 17-05-2018) in the case of Ea-Servicenten.

## 2.PHYSICAL FITNESS NORMS:-

Physical fitness norms shall be applicable as per rule 14 of RPSSR, 1989 :-

Further relaxation in Physical fitness/ standards, as admissible, shall be governed by Rule 14 of RPSSR 1989.

### 3. EDUCATIONAL QUALIFICATION:-

Educational qualification required for the post of constable as mentioned in section 1, ill and V of the Rules will be as prescribed in column IV of schedule-I of RPSSR, 1989.

## 4. VENUE FOR DOCUMENT VERIFICATION AND TRIAL --

The vertue shall be intimated by the Chairman of the recruitment Board farmed by DGP Rajasthan.

## 5. INVITING OF APPLICATIONS:-

- (a) Applicant can apply for only one game/event.
- (b) The notification for inviting ordine applications for recruitment shall be published in the leading newspapers and police website <a href="https://www.police.taimthan.gov.in">www.police.taimthan.gov.in</a>.
- (c) Candidate shall be required to submit the prescribed online application form through the common service centre (CSC)/E-mitra kioaks or at his/her own level after obtaining a token mumber from CSC/E-mitra kioak. List of the CSC/ E-mitra kioaks and instructions for filling application form shall be available on website.
- (d) Examination Fee-applicable for online application is as follows:-

Personnel (A-2) Department, Government of Rajasthan's Circular Number P-8(3) Personnel/A-2/2023/04443 dated 19-04-2023 has implemented One Time Registration system in all Recruitment Examinations. After one-time registration by the condidates, repeated examination fees need not required. For this, condidates will have to deposit onetime registration fee prescribed as per rules by going to One Time Registration option after login through his/her SSO ID.

- Unreserved/BC (Creamy), MBC (Creamy)
- SC/ST/EC(non-Creamy)/MBC (non-Creamy), EWS category candidates including TSP & Saharia.

- Handwritten application forms shall not be accepted by the Department.
- (f) On successful submission of online application form, a unique Application ID shall be allotted to the candidate.
- (g) Incomplete applications or applications not filled-up in accordance with the instructions issued shall be rejected under Rule 20 of RPSSR 1989. No claim for refund of fees shall be entertained.
- (h) The roll numbers for applications accupted online shall be allotted to the candidates on the basis of randomization. Admission cards will be uploaded on the website. Admission cards will not be sent to the candidates by post. It Shall be the responsibility of the candidates to download their admission card by using application ID from the website.

## 6. PROCEDURE FOR SELECTION:-

According to the notification dated 23-05-2022 & Amended notification dated 03-08-2024 of the State Government Personnel (A-2) Department, as per the provisions of schedule-II of the Rajasthan Subordinate and Ministerial Services (Common Eligibility Test) Rules-2022 for the post of Constable (Senior Secondary Level) of Rajasthan Police Subordinate Services, the recruitment is to be done through Common Eligibility Test.

Candidates of GEN/ EWS/ OBC/ MBC scoring-40% and SC/ST scoring-35% marks in Common Eligibility Test (Senior Secondary Level)-2024 conducted by Rajasthan Subordinate & Ministerial Staff Selection Board, will be eligible to apply online for the respective post of Constables Sports quote.

The candidates will be selected on the basis of marks given for their sports certificates and performance shown during the trial of the concerned sport/games.

#### Note:

- (a) Games that are organized every year, certificate will be valid for three years. For games that are not organized every year certificates will be valid for five years.
- (b) Only the Merit/Participation Certificates obtained in games recognized by All India Police Sports Control Board, New Delhi shall be entertained.
- (c) Only the Merit/Participation Certificates obtained in the competitions conducted by any of the following Sports bodies in the games mentioned above at point 6(i) shall be entertained: -

(d) In addition to above provision, it is clarified that only one certificate which carries maximum weightage will be emertained.

#### (ii) Physical Standard Test (PST):-

Suitable candidates shall have to go for P.S.T. as per point 2 of standing order, conducted by aport selection Board.

# Height, chest/weight measurements will be communicated and explained to each and every candidate and their signatures be taken.

Candidates failing to fulfil the prescribed physical standards shall be rejected.

#### Provision of Appeal in PST: -

One chance of appeal will be given to candidates who are not satisfied with the PST result. A fee of Rs.500/- shall be deposited by the candidate along with appeal application and he/she shall be re-examined by the Recruitment Board on the same day. To avoid any disadvantage to the candidate, the Recruitment Board Shall be assisted by a Medical Board, consisting of government doctors in all causes of PST appeals and the signatures of the candidates shall figure in all sheets of appeal along with that of the members of the Recruitment Board and Doctors of medical board. PST measurements shall be done on the day of PST with an without appeal and shall be final.

#### (iii) Trial (30 Marks)

The candidate who Pass in P.S.T. shall be required to undergo a trial for the game/sport for which he/she is applying and will be assessed out of 30 marks. The trial shall be conducted with the advice and assistance of a trial Committee comprising of at least two NIS qualified coaches nominated by the chairman of the recruitment board and a renowned player of the game, not working in Rajasthan Police.

Coaches/ renowned player for the trial, will not be called at personal level but will be called through SAI or any other sports authority. The coach/ renowned player will not be a resident of Rajasthan state or from the neighboring state. Two coaches will be called for each game/sports and shall be resident of different states.

The coaches/ referees will have to give a written undertaking that he is not related to or known to any of the candidates appearing in the recruitment process and will also give written consent that none of the candidates who came for selection has been trained by him.

The trial shall be conducted as per the rules for the sport established by the concerned National Sports Federation. The trial Committee shall assess the performance of the applicant on various technicalities the discipline in which he/she is being assessed.

A. Individual Events: The candidates of each sport will be required to compete against each other in their discipline (in their respective weight category, if any) and would be awarded marks as below, based on positions obtained in the trials:-

- a. Two marks will be deducted for every position after the 3rd position.
- b. For games in which performance is judged on the basis of time/distance/weight/ score/points the candidate must perform better or equal to the performance of third positions of time/distance/weight/ score/points achieved in the last All India Police Games.

Note:- If in case sufficient applicants are not available for a specific discipline to conduct trial, the Selection Board may summon players of that discipline who have not applied for the same to participate in the trial, to facilitate the trial Committee to assess the suitability of the candidates.

#### B. Team Events:-

The trial shall be conducted by the selection board within the parameters or rules laid down by the concerned National Sports Federation.

The candidate shall be required to score at least 50% marks (15 Marks out of 30) in the trial, failing which he/she shall not be considered for selection.

#### 7. Merit list-

Sports/Games wise merit lists shall be prepared on the basis of total marks obtained by the candidates out of 100 marks.

Candidates who fail to secure minimum of 40 marks in overall assessment out of 100 marks, shall not be considered eligible for inclusion in the merit list.

#### Note:

- (a) if only one player is available for the trial in a particular weight category in an individual event, it does not entitle him for selection. Sports Selection Board and trial Committee will assess his calibre based on his sport techniques, skills and certificate evaluation and award marks accordingly.
  - (b) The basis of selection will not be the position obtained in the individual event of any weight category/other category, but the position obtained in the soorts-wise merit list.
- (c) In case of non-availability of sortable candidate in a particular event, those vacancies shall be filled from the merit list from reserve candidates in the merit list on the basis of marks attained by them in the overall merit list.

A combined merit list shall be prepared on basis of total marks (certificate evaluation and trial) obtained by the candidate and the allotment of posts shall be done strictly as per merit cum preference basis.

#### 8. Medical Examination: -

Intimediately after declaration of the select list, candidates shall be required to undergo a Medical Test by a Government Medical Board. The Appointing Authority shall approach the Chief Medical and Health Officer/Principal Medical Officer concerned to appoint one or more medical officers, as required, for this purpose, as per enclosed proforms (Annexure D).

Candidates who are found temporarily unfit and whose defect can be rectified within 6 months as per the opinion of the Medical Officer shall be eligible for appointment after the said period, provided they are found fit by medical board.

Candidates who fail to conform to the prescribed standards of medical fitness even on re-examination within stipulated time shall be declared medically unfit for appointment and their candidature shall stand cancelled.

#### Medical standards :-

The minimum near vision should be N6 (better eye) and N9 (worse eye). The minimum distant vision should be 6/6 (better eye) and 6/9 (worse eye) of both eyes with or without any correction. In right handed person, the right eye is better eye and vice versa. (As per DOP instructions dated 13.3-2020)

The candidate must not have knock knee, that foot, variouse vein, night blindness, stammering, herms or squint in eyes and they should possess high colour vision.

They must be in good mental and bodily health and free from any physical defects surgical problems likely to interfere with the efficient performance of the duties.

#### 9-Documents Verification:

The original certificates of date of birth, easte, education and marital status (in case of women) shall be obtained from the candidates who are declared fit in the medical examination. These certificates shall be verified by the Appointing Authority and only those candidates whose documents are found genuine, shall be eligible for appointment. After verification process is complete the original certificates will be returned and photo copies shall be retained by units concerned for second.

Entry of availed reluxation in height and chest/weight measurements of SC/ST candidates should be made explicitly in their Service records.

Additionally, certificates of relevant sport and domicile will also be verified by the appointing authority.

#### 10. Churacter Verification: -

Candidates will be required to furnish a declaration in R.P. form No. 4 (Verification Roll) and the contents of such declaration, may be got verified during the character verification.

Dates should be mentioned in every document of character verification. Candidates with "satisfactory" character as per rule-13 of RPSSR 1989 shall be eligible for appointment.

Monters related to disqualification due to incomplete/ fraudulent documents relating to character verification or due to criminal antecedents shall be referred for decision to the Police Hendquarters.

Narms prevalent at the time of conduct of character verification shall be applicable in deciding suitability of a candidate for appointment.

#### 11. No Objection Certificates: -

Candidate already working with Govt, of India/State Govt./Public Sector Organizations will be required to submit a No objection Certificate from the concerned employer, at the time of trial

#### 12. Determination of Seniority:-

- I. The candidates recruited under this process shall be treated junior to recruitment made otherwise under the Rules for the same year.
- II. Amongst the candidates recruited under this Rule, seniority will be decided on the basis of marks, obtained in overall assessment, i.e. out of 100 marks. If two or more candidates obtain equal marks, the person older in age shall be placed higher. Where two or more persons have same marks and age, the person having higher calicational qualification will be placed higher. Where two or more persons have same marks, age and educational qualifications, their names shall be placed in English alphabetical order in the seniority list.

Candidates standing higher in merit shall be eligible for appointment subject to the provisions of Rajasthan Police Subordinate Service Rules: 1989

In the case of candidates belonging to Scheduled Custes and Scheduled Tribes and Saharin, relaxation in physical measurements is available only if candidates fulfilling the prescribed measurements are not available. The Selection Board shall take case to segregate the candidates who have taken relaxation of physical measurements and those who have not. When such candidates are included in the select list they will find place below the candidates who have not availed themselves of any relaxation.

Note: -Selected personnel may be stationed at one location for practice/ preparation of State/ National level events for any period decided by the Chief Sports officer of Rajusthan Police with the permission of Director General of Police.



After selection of the candidates the floard will allot them various units as per vacancies through organizing counselling session and shall forward the select list with recommendations of the board to DGP office giving details of their categories etc. The decision on allotment to various units will be finally decided by the DGP.

#### 13. APPOINTMENT: -

Medically fit candidates whose documents are found genuine and against whom nothing adverse has come to notice on verification of their character, shall be appointed strictly on the basis of their merit on probation.

Upon selection, the candidate shall be required to furnish a bond as deemed fit by the appointing authority.

If a candidate is disqualified on any ground or fails to join by the date given by the appointing authority, the candidate next in the merit list in the order of merit shall be eligible for appointment.

#### 14.DISQUALIFICATION FOR APPOINTMENT:-

A candidate shall be disqualified for appointment if his candidature is found violative of RPSSR 1989. Any candidate who is found to be guilty of impersonation or submitting fabricated documents, suppressing material information's e.g. concealing information about criminal cases pending or disposed against him/her, using or attempting to use unfair means during the examination, otherwise resurting to any other irregular or improper means for obtaining admission in addition to rendering himself herself liable to criminal prosecution, will be debured either permanently or for a specified period by the DGP for admission to any examination to be held under the provisions of those Rules.

His/her conduct may also be reported to the State Government for similar action in respect of various services under the State Government. Candidates who have furnished wrong or have suppressed any information including those related to criminal cases pending or disposed, shall not be eligible for appointment.
